I. Call to Order:

A regular meeting of the board of the Krewe of St. Andrews, Inc. was called to order by Lee Head at 5:30 pm.

II. Approval of Minutes:

III. Treasurer's Report/Approval:

Don reported that we still have \$899.20 left from member donations toward chairs, tables, carts and linens. Don suggested that we put these funds toward: 1 chair dolly, 2 round table dollies and 40 chairs. Sandy Harrison moved to approve, seconded by Charlie Coram, motion passed.

Don also reported that the new AV system is in good working order. We still need to install the security system.

IV. Krewe Business:

Chris Pfhal gave a report on the progress of the Mardi Gras Festival. He has 2 barricade rentals scheduled, 6-10 vendor spots are still available for the MG Festival. He confirmed approval for individual political candidates to participate in our parade (Mark Sheldon, candidate for PCB Mayor). He may be able to schedule the FSU Cheerleaders for our festival. Destination Panama City provided \$7500.00 for event expenses. They are also providing up to 25 feather flags for our (and their) use. Chris will try to get 4 - 6 KOSA feather flags in the mix as well for our personal krewe use. Sandy Harrison will seek designs for our krewe flags. Lewis Bear Co. is providing a 40 foot long trailer to be used as a bar.

V. Committee Reports:

Parade Committee - Tina Head reported that Walborsky & Bradley Law Firm will be our Pet Parade Sponsor this year (\$2500.00 value) Pam Wiggins reported on the kids parade with approximately 20 community groups involved. We will have all 11 krewe floats involved in the kids parade.

Sponsorship Committee - Lee Head will finalize the sponsorship brochure. The board approved the new mission statement.

Den Rental Committee: Valerie Anderson presented a draft of the den rental information. She reported on the various social media sites: @KOSAevent center, kosaeventcenter.com. Approval was given by the board for her to get business cards printed for den rental purposes.

VI. Old Business:

The new float barn is almost complete. Garage doors are scheduled to be installed within the next week as well as interior lighting.

Lee Head initiated discussion on the Krewe becoming a sponsor for the Covenant Care Mask Ball. The board declined this offer.

VII. New Business:

Lee Head presented research on the costs, design, etc. for a brand new trailer to be used as a bar/merchandise fundraising trailer at various community events. The approximate cost is \$21,000.00. Lee will head up a membership fundraising drive to help sponsor aquiring this trailer from Georgia Trailer Showroom.

Don Cox requested help in notifying past due members (if personally known to us) to pay their dues. He also requested board approval to replace the old, barely working krewe printer. He requested \$450.00, board approved this request.

George Anderson reported there will not be a need for any floats to be outside during the 12th Night Blessing of the Floats event. Some floats will be staged in the new float barn. He also reported that there will be an auxiliary bar in the main float barn during the party. George requested up to \$1200.00 to assist in repair of his float. He stated he has already spent \$765.00 for materials. The board approved his request.

Sandy Harrison inquired about the Krewe posters. She will coordinate gathering these posters and re-framing them to be hung in the den.

Lee Head called for any member announcements, none were given.
