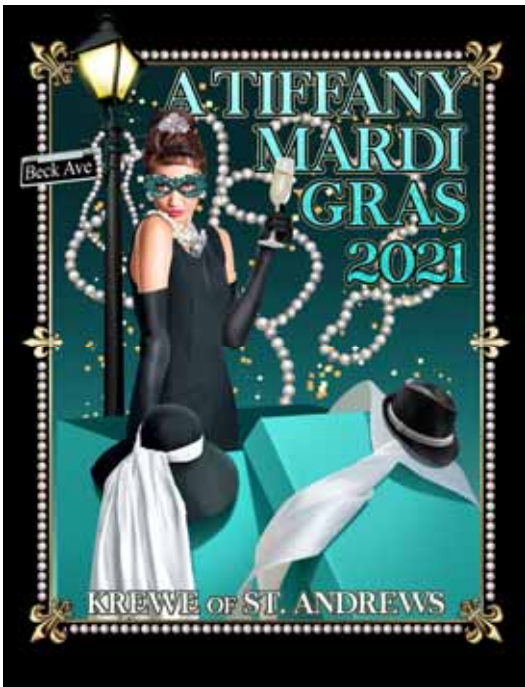
## A Message From The King and Queen

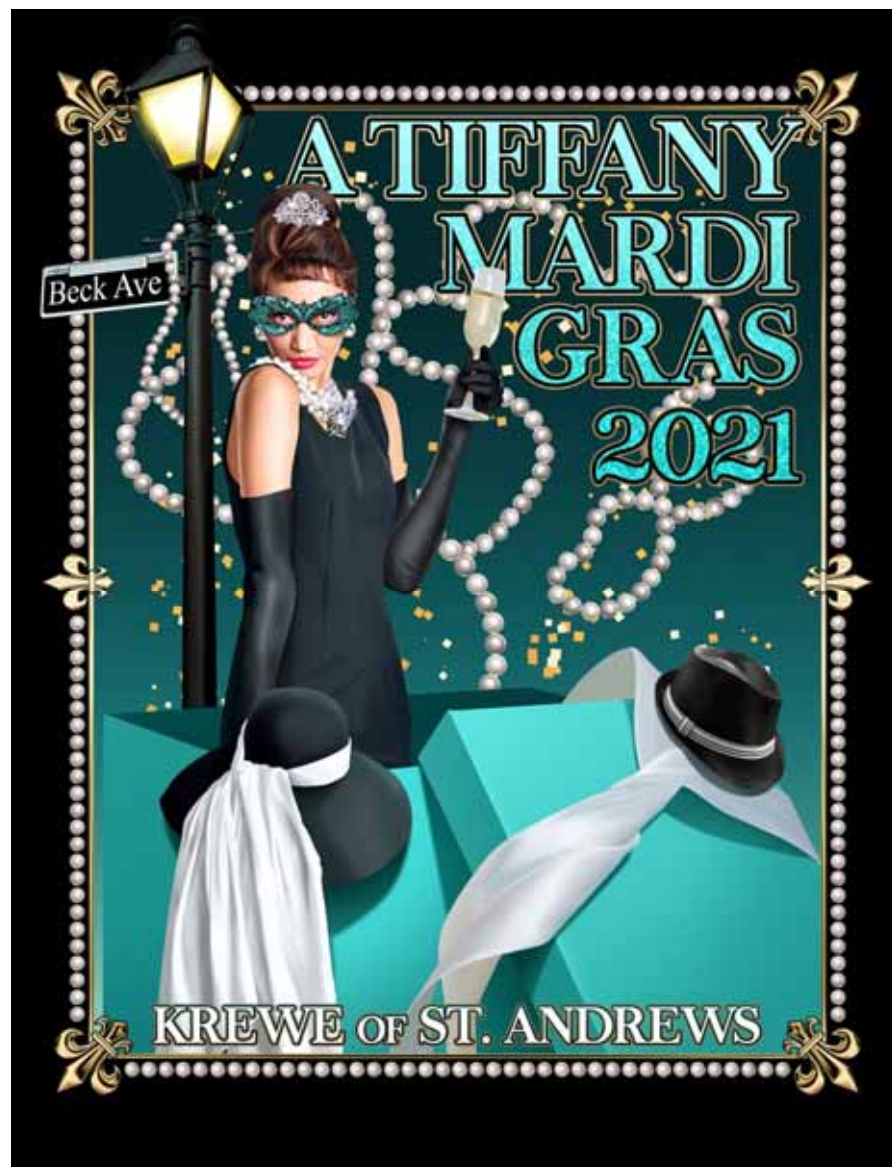

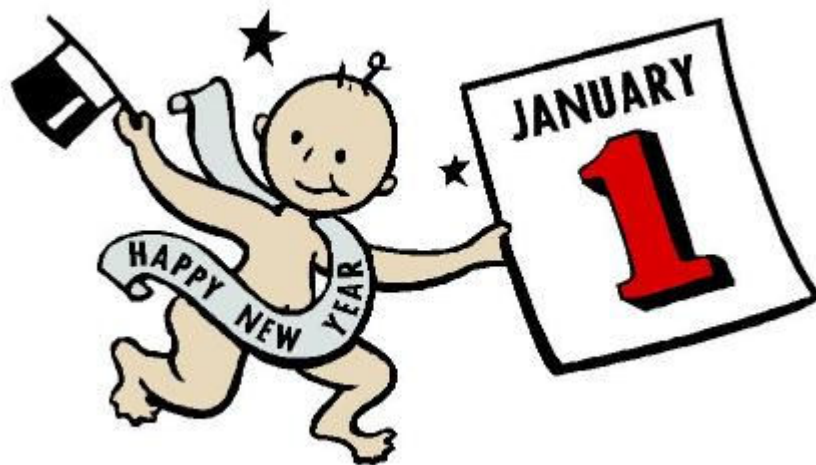
