    - Not sure about the location of Marina.
    - Keeping City parking for the Krewe by the boat ramp.
    - Road blocking is from the boat ramp.
  - Porta Potties for Kids' Parade one at clubhouse and one at Bayview and 15th street, Main Parade 1 on KODY side, 1 on 12th street, KOSA uses park facility.
  - Clarification on Pet Parade
    - (registration at 1, judging at 1:45, parade at 2:30 from Park to Stage)
  - Tina Head working on the Drum Line for Masked Parade to travel down Bayview.
    - Lofty Pursuits is a possibility
  - Chris said he has 2 groups to wheel walk, Board Agreed \$100 for 8 wheel walkers provided (16 or older)
  - No Grand Marshall at this time
  - Marketing- Chris reported that Aaron Rich and DPS have an agreement- Lee and Tina have a meeting to discuss advertising...possibly going somewhere else. \$10,000 Electronic billboards, radio and TV, DPC is doing \$5000 in house advertising.
